

TEN YEAR NON-TRANSFERABLE LIMITED WARRANTY ON HOMESTYLES SHEDS

What is covered: Barrette Outdoor Living warrants its Homestyles sheds against defects in materials or workmanship for ten (10) years from the date of purchase. Barrette Outdoor Living warrants these products against peeling, flaking, splintering, rotting or abnormal discoloration under normal use and service. This warranty extends to the original purchaser and is not transferable. Further, this warranty only applies to products registered with Barrette Outdoor Living by the original purchaser. Failure to register product or failure to assemble product in accordance with provided assembly instructions (including anchoring shed to base) will void warranty. Product can be registered at www.homestylesshed.com or using the mail in registration card provided with your product.

What this warranty does not cover: This limited warranty does not cover damage resulting from accident, improper or unreasonable use, neglect, alteration, improper service, improper installation, acts of God or any other causes not arising out of defects in materials or workmanship. Additionally, this warranty does not cover color change due to normal weathering of the product. For purposes of this warranty, "Normal weathering" includes exposure to ultraviolet sunlight which would cause any colored or painted surface to fade, chalk, or darken. Additionally, this warranty does not cover costs of installation, removal, reinstallation or surface mold and mildew created by excessive environmental conditions.

Specifically on metal parts - Damage from rust caused by conditions beyond seller's control: The Limited Warranty will be void if the product rusts due to reasons other than non conformities in material and workmanship, including without limitation, rust arising from misuse, abrasions, environmental conditions, solvents, corrosives, salts, chemicals, excessive moisture or any other damage due to normal wear and tear that could have been addressed by routine, timely, and proper corrective maintenance. Steel component products, particularly those installed within five (5) miles of a body of salt water, require prompt and careful maintenance by Warranty Holder, including periodic cleaning, finishing and refinishing, and other repairs in accordance with published product maintenance recommendations in order for this Limited Warranty to remain effective.

Specifically on the doors - Minor scratches or minor imperfections are not covered. Doors must be painted with a suitable exterior paint within 10 days of installation. Any rust or other damage resulting from lack of painting within this time frame will not be covered by this warranty.
